Minutes of the Regular Meeting of August 24, 2021

- B. Open Forum: Mayor Lovero opened the floor for Open Forum. He recognized the following people who spoke to the City Council: BDC Dir. David Hulseberg, Darrel Allen, Berwyn Police Dept. Community Relations Specialist Angie Grozdic, and Ald. Lennon
- C. Approval of Minutes:
 C-1: Ald. Pabon made the motion, seconded by Ald. Carmichael, to correct the Minutes of the August 10, 2021 Regular Meeting to mark him as Present for the roll call and to amend the Minutes at I-2 to include mention that his communication commended Congresswoman Cori Bush and President Joseph R. Biden for their efforts to extend the federal eviction moratorium. The motion carried by a unanimous voice vote. Ald. Lennon made the motion, seconded by Ald. Arenella, to approve the Committee of the Whole Minutes as submitted and the Regular Meeting Minutes as corrected and amended. The motion carried by a unanimous voice vote.
