

# MINUTES Regular Berwyn City Council Meeting February 25, 2020

#### A. Meeting Opening:

Mayor Lovero called the Regular Meeting of the City Council to Order at 8:00 P.M. Aldermen Lennon, Ramirez, Reardon, Fejt, Santoy, Ruiz, Avila, and Nowak answered Present on the Call of the Roll. Mayor Lovero led the Council and those in attendance in the Pledge of Allegiance. He asked for a moment of silence in memory of former City Clerk Donald Pechous and for the safety of our local First Responders.

#### B. Open Forum:

- Ms. Orozco from St. Odilo Parish announced the parish's Mardi gras dinner dance and raffle. She invited local business to be sponsors of the event.
- BDC President Andy Sotirapoulis explained the Illinois' tax revenue change regarding video gaming terminals and the effect on business owners with gaming machine licenses.
- Ald. Avila distributed information on the upcoming Census.

#### C. Approval of Minutes:

Motion by Ald. Avila, seconded by Ald. Fejt, to approve the Committee of the Whole and Regular City Council Minutes of February 25, 2020 as submitted. The motion carried by a unanimous voice vote.
