- 12. The Assistant City Administrator submitted a communication regarding the Renewal of General Liability Insurance. Thereafter, Chapman made a motion, seconded by Boyajian, to concur, approve as submitted, authorize the Mayor to execute a contract with Princeton, authorize the corporate authorities to affix their signatures thereto and approve for payment in the amount not to exceed \$263,824. The motion carried by a unanimous roll call vote.
- 13. The Assistant City Administrator submitted a communication regarding the Renewal of Excess Workers' Compensation Insurance (Workers' Compensation above \$800,000). Thereafter, Chapman made a motion, seconded by Boyajian, to concur, waive the bid process, approve as submitted, authorize the Mayor to execute a contract with Safety National, authorize the corporate authorities to affix their signatures thereto and approve for payment in the amount not to exceed \$122,433. The motion carried by a unanimous roll call vote.
- 14. The Acting Police Chief Cimaglia submitted a communication requesting approval to authorize the hiring of two Probationary Police Officers from the current Fire and Police Commissioner's Eligibility List. Thereafter, Avila made a motion, seconded by Polashek, to concur and grant permission. The motion carried by a voice vote.
- 15. The Finance Director submitted a communication regarding the 2016 Tax Levy (to be collected in 2017) with a 0% increase. Thereafter, Chapman made a motion, seconded by Avila, to accept as informational. The motion carried by a voice vote.
- 16. The Public Works Director submitted a communication requesting approval to proceed with the Request for Proposal for the Green Alley replacement project. Thereafter, Boyajian made a motion, seconded by Chapman, to concur and grant permission. The motion carried by a voice vote.
