MINUTES BERWYN CITY COUNCIL JUNE 12, 2012

- 1. The regular meeting of the Berwyn City Council was called to order by Mayor Lovero at 8:00 p.m. Upon the call of the roll, the following responded present: Chapman, Boyajian, Paul, Skryd, Polashek, Avila and Laureto. Absent: Santoy. Thereafter, Avila made a motion, seconded by Polashek, to excuse Alderman Santoy. The motion carried by a voice vote.
- 2. The Pledge of Allegiance was recited and a moment of silence was had for the family of the deceased Felix Hernandez, Marie Comella, wife of Water Department Vince Comella and for former Alderman Raymond Cox and for the Men and Women on the streets of Berwyn protecting our safety, along with the Men and Women in the Armed Forces.
- 3. The Open Forum portion of the meeting was announced. The Mayor recognized members of the Berwyn Development Corporation Depot District Special Events Committee who presented a \$1,000 check to the Berwyn Fire Department Honor Guard from the proceeds of the Depot District Pub Crawl. Alderman Avila spoke regarding two items, first being the Cook County Animal Control preformed Veterinarian services today at the 16th Street VFW for over 100 participants, for vaccinations and micro chipping their animals at discount rates. Also announced that June 16th North Berwyn Park District is having Grand Opening for the Berwyn Gardens, just West of Home Ave. at 9:30 A.M.
- 4. The minutes of the Berwyn City Council Meeting and the Committee of the Whole held on May22, 2012 were submitted. Thereafter, Avila made a motion, seconded by Polashek, to concur and approve as submitted. The motion carried by a voice vote, with Skryd Abstaining.

5. Chapman made a motion, seconded by Boyajian, to suspend the rules and bring forward item G-1. Kenneth Fron, Berwyn Fire Department. Polashek made a motion, seconded by Laureto, to **adopt** the proclamation as presented. The motion carried by a voice vote. Thereafter, the Mayor recognized Lt. Fron and presented him with the Proclamation.
- 7. Fire Department Chief O'Halloran submitted a communication regarding the introduction and swearing in of Felix Greco to the rank of Lieutenant in the Berwyn Fire Department. Avila made a motion, seconded by Laureto, to concur and approve the appointment as submitted. The motion carried by a voice vote. Thereafter, Clerk Pavlik administered the oath of office.
- 8. Fire Department Chief O'Halloran submitted a communication regarding introduction and swearing in of Derek Mijares to the rank of Engineer. Avila made a motion, seconded by Polashek, to concur and approve the appointment as submitted. The motion carried by a voice vote. Thereafter, Clerk Pavlik administered the oath of office.

- 15. The Mayor submitted a correspondence regarding the retirement of Ben Pennacchio, Commander of Commodore Barry Post 256, also thanking Alderman Laureto and her team of Patricia James and Kelly Cimaglia for honoring are fallen veterans on Memorial Day by decorating the Memorial at Commodore Barry Post. Thereafter, Avila made a motion, seconded by Skryd, to accept the matter as informational. The motion carried by a voice vote.
- 16. The City Clerk submitted a communication regarding proposed amendment to Chapter 209, Ethics Provision 209.08(E)
 Reimbursements of Expenses. Thereafter, Paul made a motion, seconded by Skryd, to defer the matter. Discussion ensued. A motion was made by Chapman, seconded by Boyajian to concur and refer the matter to the Law Department to draft an amended ordinance. The Mayor asked for a vote on the first motion to defer the matter. The motion was defeated on the following call to roll: Yeas: Paul, Skryd. The motion carried on the following call to roll: Yeas: Chapman, Boyajian, Santoy, Polashek, Avila and Laureto. Nays: Paul, Skryd.
