MINUTES BERWYN CITY COUNCIL JANUARY 25, 2011

- I. The regular meeting of the Berwyn City Council was called to order by Mayor Lovero at 8:00 p.m. Upon the call of the roll, the following responded present: Chapman, Boyajian, Paul, Skryd, Santoy, Polashek Avila, Laureto.
- 2. The Pledge of Allegiance was recited and a moment of silence was observed for the deceased Amelia "Amy" Smith, former Berwyn Employee, Collector's office, for the deceased Edward Luckey, grandfather of wife of Firefighter Derek Mijares and brother-in-law of building department employee Kitty Rohmann, for the deceased Floyd Mullennax, father-in-law of Firefighter Robert Fejt and for the men and women on the streets of Berwyn protecting our safety.
- 3. The Open Forum portion of the meeting was announced. The Mayor thanked public works employees and public works Director Schiller for the work done over the weekend on a water main break. Director Schiller thanked the fire and police department for their support and traffic control. Alderman Avila reminded all of the Tax Appeal Workshop to be held on Wednesday, January 26, 2011 at the VFW Hall on Harlem Avenue and 16th Street.
- 4. The minutes of the regular Berwyn City Council meeting, and the Committee of the Whole, for December 28, 2010 were submitted. Thereafter, Skryd made a motion, seconded Boyajian, to concur and approve as submitted. The motion carried by a voice vote.
