MINUTES BERWYN CITY COUNCIL May 10, 2011

- 1. The regular meeting of the Berwyn City Council was called to order by Mayor Lovero at 8:05 p.m. Upon the call of the roll, the following responded present: Boyajian, Paul, Santoy, Polashek, Avila, Laureto. Absent: Chapman, Skryd. Thereafter, Avila made a motion, seconded by Polashek, to excuse Alderman Chapman and Alderman Skryd. The motion carried by a voice vote.
- 2. The Pledge of Allegiance was recited and a moment of silence was observed for the men and women in the armed forces especially in light of the recent events in the Middle East and for the men and women on the streets of Berwyn protecting our safety.
- 3. The Open Forum portion of the meeting was announced. The Mayor recognized resident, David Olson, president of the Berwyn Historical Society who spoke on the purchase of a building on the south east corner of 14th and Grove Ave. to house the Berwyn Historical Society and wanted to thank the Mayor and Alderman Laureto for their assistance in this matter. Alderman Laureto welcomed the Berwyn Historical Society to the 8th ward. The Mayor spoke regarding FEMA's reimbursement in the amount of approximately \$195,000 which was reimbursed for the snow emergency this past winter.

- 13. The City Administrator submitted a communication regarding recommendation to hire an architect for the library elevator design only. Thereafter, a motion by Laureto, seconded by Polashek, to concur and approved as submitted. The motion carried by a unanimous roll call vote.
- 14. The City Administrator submitted a communication regarding approval for staff to develop and disseminate RFP's via our sealed bid process for both an elevator and a general contractor.
