MINUTES BERWYN CITY COUNCIL FEBRUARY 25, 2009

- 1. The regular meeting of the Berwyn City Council was called to order by Mayor O'Connor 8:00 p.m. Upon the call of the roll, the following responded present: Chapman, Ramos, Weiner, Day, Phelan, Lovero, Erickson. Absent: Skryd. Thereafter, Ramos made a motion, seconded by Chapman, to excuse Alderman Skryd. The motion carried.
- 2. The Pledge of Allegiance was recited and a moment of silence was observed for the safety of our armed forces, police, firefighters, and paramedics.
- 3. The Open Forum portion of the meeting was announced. The Mayor recognized Cook County Commissioner, Tony Perica, who reported on the State of the County budget and reported that there will be no new tax increases in the \$3.2 billion dollar budget and that the budget included Capital projects through Bond issues. There being no further speakers, the Open Forum portion was declared closed.
- 4. The minutes of the regular meeting and the Committee of the Whole held on February 10, 2009 were submitted. Thereafter, Erickson made a motion, seconded by Ramos, to concur and approve as submitted. The motion carried by a voice vote.
- 5. The Mayor submitted a Proclamation honoring Alderman Thomas J. Day for the Distinguished Service Award. Thereafter, Lovero made a motion, seconded by Ramos, to concur and adopt the proclamation as presented. The motion carried. Thereafter, the Mayor recognized and presented the proclamation to Alderman Thomas J. Day. Alderman Skryd present at 8:15 p.m.
- 6. The Mayor submitted a Proclamation honoring dispatchers Jesus Carillo, Lisa Coleman, and Monica Wilk, Police officers Carl Gray, Guy Papa and Donald Wilhite, regarding the incident which occurred on February 7, 2009, wherein an armed robber was apprehended. Thereafter, Lovero made a motion, seconded by Skryd, to concur and adopt the proclamation as presented. The motion carried by a voice vote.

Thereafter, Clerk Pavlik administered the oath of office. Thereafter, Lovero made a motion, seconded by Skryd, to concur and approve the appointment as submitted. The motion carried by a voice vote.
- 8. The Mayor submitted a communication regarding Lombard Avenue parking. Thereafter, Erickson made a motion, seconded by Skryd, to refer the matter to the Traffic Engineer. The motion carried by a voice vote.

The motion failed for lack of a second. Thereafter, Lovero made a motion, seconded by Ramos, to defer the matter for 2 weeks. The motion carried by a voice vote with Weiner voicing a contrary nay.
- 12. The Mayor submitted a communication regarding the Handicap sign for Elba Ramos, 1848 Elmwood Avenue. Thereafter, Phelan made a motion, seconded by Ramos, to concur and approve the handicap sign as requested. The motion carried by a unanimous roll call vote.
- 13. A deferred communication from Alderman Erickson regarding a Temporary building at St. Mary of Celle. After discussion, Erickson made a motion, seconded by Weiner, to concur and override the decision of the building director, and grant permission to allow 1 modular unit.
