MINUTES Regular Berwyn City Council Meeting March 13, 2018



- The Regular Meeting of the Berwyn City Council was called to order by Mayor Lovero at 8:00 p.m. The following Aldermen responded present upon the call of the roll: Lennon, Ramirez, Reardon, Fejt, Santoy, Ruiz, Avila and Garcia.
- The Pledge of Allegiance was recited. A moment of silence was given for the safety of the men and women
 protecting us on the streets of Berwyn, for those who are in the Armed Forces, and for all Veterans who
 have served.
- 3. The Open Forum portion of the meeting was announced. The Mayor recognized members of Girl Scout Troop 402. Anthony Nowak spoke regarding St. Joseph annual fundraiser/celebration on March 16th at the Italian-American Civic Organization. Reardon announced a 3rd Ward meeting in conjunction with the 2nd Ward on March 15th at 6:30 at Unity Lutheran Church. Ruiz reminded everyone of a 6th Ward meeting on March 15th at 6:30 pm at the Italian American Civic Organization. Garcia announced an 8th Ward meeting on April 4th at 6:30 pm at St. Mary of Celle.
- 4. The Minutes of the regular Berwyn City Council and of the Committee of the Whole meetings held on February 27, 2018 were submitted. Ruiz made a motion, seconded by Santoy, to correct the Council minutes to include Ruiz within item #1 and amend item #3 to state the 5th Ward meetings to be held on the forth Thursdays of each month through October, 2018. - 5. Berwyn Development Corporation submitted a communication requesting Loan Approval for The Berwyn Bottega. BERWYN CITY COUNCIL MINUTES of the COMMITTEE OF THE WHOLE MARCH 13, 2018

Mayor Lovero called the Committee of the Whole to order at 6:00 p.m. A roll call was taken. The following Aldermen answered present: Ramirez, Reardon, Fejt, Santoy, Ruiz, and Avila. Avila made the motion, seconded by Santoy, to excuse Aldermen Lennon and Garcia. The motion passed on a voice vote. Mayor Lovero then introduced the following agenda items:

- 1. 2018 Draft Budget Document Distribution: Finance Director Rasheed Jones was recognized. A copy of the 2018 City of Berwyn Draft Budget was distributed to the council members. Mr. Jones gave a brief account of the process entailed in compiling the budget. Questions ensued.
- 2. Berwyn Free Library Initiative: Berwyn resident Rob Pabon was recognized and gave a power point presentation on his program to increase Free Libraries stationed on private and public property. The program utilizes the "Little Free Library" national non-profit organization model. Mr. Pabon informed the council of the plan to implement a 5th Ward initiative that will hopefully grow to include many more Berwyn neighborhoods. Discussion ensued.
- 3. Regional Disposal Project Presentation. City Administrator Pabst and Mr. Neil James, Executive Director of the West Cook Solid Waste Agency were recognized. Mr. Pabst explained the service performed by the agency and the benefits of participation in the program. A renewal of the participation agreement is on the upcoming council agenda. Questions from council members and discussion ensued.
- 4. Extension of Waste Management Contract: Presentation: Mr. Pabst was again recognized along with Waste Management Representatives Vaughn Kuerschner and Jim Gann. Mr. Pabst explained the terms of the Waste Management renewal contract to be considered by council. Due to anticipated savings through the West Cook Solid Waste agreement, the city can provide residential hazardous waste pick up service as a part of the Waste Management contract. The new service will begin in September, 2018 at no additional cost to residents. Questions by council members and discussion ensued.
- 5. At the request of the Mayor, Lennon made a motion, seconded by Ruiz, to go into Closed Committee of the Whole for discussion of contract negotiations and pending litigation. The motion passed by a voice vote. The Council adjourned to go into closed session at 6:48 p.m.
- 6. The Council returned to the open session at 7:35 p.m. Avila motioned, seconded by Fejt, to adjourn the Committee of the Whole. The motion passed by voice vote.
- 7. The Committee of the Whole was adjourned at 7:35 p.m.

ORDINANCE NO.

THE ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF BERWYN, COOK COUNTY, ILLINOIS FOR THE FISCAL YEAR 2018

WHEREAS, the City of Berwyn, Cook County, Illinois (the "City") is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the Codified Ordinances of the City of Berwyn and Section 8-2-9 of the Illinois Municipal Code (65 ILCS 5/8-2-9) require the adoption of an ordinance within the first quarter of each fiscal year, to be termed the annual appropriation ordinance, appropriating such sums of money as are deemed necessary to defray all necessary expenses and liabilities of the municipality and which specifies the objects and purposes for which these appropriations are made and the amount appropriated for each object or purpose (the "Annual Appropriation Ordinance"); and

WHEREAS, as required by applicable law, notice of a public hearing on the proposed Annual Appropriation Ordinance was published in a newspaper published in the City at least ten (10) days before the time of the public hearing; and

WHEREAS, such public hearing was held on March 27, 2018, with all wishing to speak being heard; and

WHEREAS, in accordance with applicable law, City staff prepared a proposed Annual Appropriation Ordinance or a formally prepared appropriation or budget document upon which this Ordinance is based, which has been and is currently conveniently available for public inspection in the office of the City Clerk; and

WHEREAS, the Mayor and the City Council have reviewed the Annual Appropriation Ordinance for fiscal year 2018 and have determined that said appropriations are in the best interests of the City and its residents; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the City Council of the City of Berwyn, County of Cook, State of Illinois, in the exercise of the City's home rule powers, as follows:

SECTION 1: That the above recitals and legislative findings are incorporated herein and made a part hereof, as if fully set forth in their entirety.

SECTION 2: The following sums of money for each City fund, or as much thereof as may be authorized by law, be and are hereby appropriated for the corporate purposes and objects of the City hereinafter specified for the fiscal year commencing January 1, 2018 and ending on December 31, 2018.

- **SECTION 3:** All the appropriations herein made for any purpose shall be regarded only as a maximum amount to be expended under the respective appropriation funds, shall not be construed as a commitment, agreement, obligation or liability of the City, and each such appropriation being subject to further approval as to the actual expenditure thereof by the Mayor and City Council of the City.
- **SECTION 4:** To the extent allowed by applicable law, any unexpended balance of the appropriations for the fiscal years prior hereto are hereby specifically reappropriated for the same fund purposes for which they were originally made and may be expended in making up any insufficiency in any item or items provided in this Ordinance without supplemental appropriation.
- **SECTION 5:** The sums as set forth in Exhibit A, attached hereto and incorporated herein, or so much thereof as may be authorized by law and needed or deemed necessary, are hereby appropriated to defray and pay all necessary expenses and liabilities of the City and such appropriations are hereby made for the objects and purposes as set forth in Exhibit A.
- SECTION 6: The City Clerk is hereby authorized and directed to publish this Ordinance in pamphlet form or in a newspaper of general circulation within the City within thirty (30) days after its adoption. The City Clerk is further authorized and directed to file a certified copy of this Ordinance with the Cook County Clerk within thirty (30) days of its adoption and the Chief Fiscal Officer of the City is authorized to certify to the Cook County Clerk that the Estimate of Revenues by Source, incorporated herein by reference, is a true statement of said revenues, which Estimate of Revenues by Source shall also be filed with the Cook County Clerk within said thirty (30) day period. The officers, employees and/or agents of the City shall take all actions necessary or reasonably required to carry out, give effect to and consummate the intent of this Ordinance and shall take all actions in conformity therewith. The officers, employees and/or agents of the City are specifically authorized and directed to draft and disseminate any and all necessary forms to be utilized in connection with the terms and purpose of this Ordinance.
- **SECTION 7:** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.
- **SECTION 8:** All ordinances in conflict herewith are hereby repealed to the extent of such conflict.
- **SECTION 9:** Any non-preemptive state statute in conflict hereof with this Ordinance is hereby superseded to the full extent of such conflict pursuant to the exercise of the home rule powers of the City.
- **SECTION 10:** This Ordinance shall be in full force and effect after its passage, approval and publication as provided by law.
