September 27, 2016

1. The regular meeting of the Berwyn City Council was called to order by Mayor Lovero at 8:00 p.m. Upon the call of the roll, the following responded present: Chapman, Boyajian, Paul, Fejt, Santoy, Polashek, Avila and Laureto.
2. The Pledge of Allegiance was recited and a moment of silence was given for the family of Guadalupe (Lupe) Mora, niece of Berwyn employee Josie Mora and for the men and women protecting our safety on the streets of Berwyn, in the Armed Forces and for all Veterans.
3. The open forum portion of the meeting was announced. There being no speakers, the open forum portion of the meeting was declared closed.
4. The minutes of the regular Berwyn City Council and of the Committee of the Whole meetings held on September 13, 2016 were submitted. Thereafter, Avila made a motion, seconded by Laureto, to concur, approve as submitted and place same on file for audit. The motion carried by a voice vote.
5. The Mayor submitted a communication regarding the appointment of Lisa Napoles to the Historic Preservation Commission. Chapman made a motion, seconded by Boyajian, to concur and approve as submitted. The motion carried by a voice vote. Thereafter, Clerk Pavlik administered the Oath of Office.
6. The Mayor submitted a Proclamation regarding "International Walk to School Day." Thereafter, Avila made a motion, seconded by Laureto, to concur and **adopt** the proclamation as presented. The motion carried by a voice vote.
7. The City Clerk submitted a communication regarding the approval of Closed Committee of the Whole minutes of August 23, 2016. Thereafter, Avila made a motion, seconded by Laureto, to concur and approve as submitted. The motion carried by a voice vote.
8. Alderman Polashek submitted the minutes of the Recreation Committee meeting held on September 6, 2016. Thereafter, Polashek made a motion, seconded by Boyajian, to accept as informational. The motion carried by a voice vote.
9. The Finance Director submitted a communication regarding the 2016A Bond and an attached ordinance entitled:

AN ORDINANCE AUTHORIZING AND PROVIDING FOR THE ISSUANCE OF GENERAL OBLIGATION BONDS, SERIES 2016A, OF THE CITY OF BERWYN, COOK COUNTY, ILLINOIS, IN THE AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$25,000,000 FOR THE PURPOSE OF ADVANCE REFUNDING A PORTION OF THE CITY'S OUTSTANDING BONDS AND PAYING FOR THE COSTS OF CERTAIN CAPITAL PROJECTS AND COSTS RELATED THERETO AND TO THE ISSUANCE OF SUCH BONDS, AUTHORIZING THE EXECUTION OF A BOND ORDER AND AN ESCROW AGREEMENT IN CONNECTION THEREWITH, PROVIDING FOR THE LEVY AND COLLECTION OF A DIRECT ANNUAL TAX FOR THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON SAID BONDS, AND





COMMITTEE OF THE WHOLE
September 27, 2016

1. Mayor Lovero called the Committee of the Whole to order at 7:00 p.m.; upon the call of the roll the following responded present: Chapman, Paul, Fejt, Santoy, Polashek, Avila and Laureto. Absent: Boyajian. Thereafter, Avila made a motion, seconded by Laureto, to excuse Alderman Boyajian. Motion carried.

Note: Alderman Boyajian present at 7:01 p.m.

2. 2016 Refinancing Bond Presentation: The Mayor recognized Finance Director Rasheed Jones and Financial Advisor Dan Denys who gave a Power Point presentation. Jones reviewed the Initial Phase – Basic Restructuring from 2009-2011. The Second Phase – Financial Enhancement 2012- 2015 and the current Phase – to address future needs. Denys reviewed the City of Berwyn positive fund balance and its history, which was a combination of bond restructuring and positive budget management on the part of the City. Denys reviewed the 2016 Financial Plan, which will be for refinancing the 2007 Bond issue and to defease (pre pay) the proposed bond issue out of the \$7.2 mil fund balance, noting this bond issue will save the City over \$10 million. Denys reviewed the next phase in the financial plan which will provide for the future. Both Denys and Jones were available for any questions.
3. There being no further business for the Committee of the Whole, the Mayor asked for a motion to adjourn. Thereafter, Avila made a motion, seconded by Laureto, to adjourn the Committee of the Whole at 7:34 p.m. The motion carried.
