- 7. The City Clerk submitted a communication regarding the approval of Closed Committee of the Whole minutes of August 23, 2016. Thereafter, Avila made a motion, seconded by Laureto, to concur and approve as submitted. The motion carried by a voice vote.
- 8. Alderman Polashek submitted the minutes of the Recreation Committee meeting held on September 6, 2016. Thereafter, Polashek made a motion, seconded by Boyajian, to accept as informational. The motion carried by a voice vote.

- 2. 2016 Refinancing Bond Presentation: The Mayor recognized Finance Director Rasheed Jones and Financial Advisor Dan Denys who gave a Power Point presentation. Jones reviewed the Initial Phase Basic Restructuring from 2009-2011. The Second Phase Financial Enhancement 2012- 2015 and the current Phase to address future needs. Denys reviewed the City of Berwyn positive fund balance and its history, which was a combination of bond restructuring and positive budget management on the part of the City. Denys reviewed the 2016 Financial Plan, which will be for refinancing the 2007 Bond issue and to defease (pre pay) the proposed bond issue out of the \$7.2 mil fund balance, noting this bond issue will save the City over \$10 million. Denys reviewed the next phase in the financial plan which will provide for the future. Both Denys and Jones were available for any questions.
- 3. There being no further business for the Committee of the Whole, the Mayor asked for a motion to adjourn. Thereafter, Avila made a motion, seconded by Laureto, to adjourn the Committee of the Whole at 7:34 p.m. The motion carried.
