The regular meeting of the Berwyn City Council was called to order by Mayor Lovero at 8:00 p.m. Upon the call of the roll, the following responded present: Boyajian, Paul, Fejt, Santoy, Polashek, Avila and Laureto. Absent: Chapman. Thereafter, Avila made a motion, seconded by Polashek, to excuse Aldermen Chapman. The motion carried.
- 2. The Pledge of Allegiance was recited and a moment of silence was given for the family of James Vizek, beloved grandfather of Berwyn Police Auxiliary/Booking Officer Anthony Vizek and for the family of Albert Jacobsen, beloved grandfather-in-law of Berwyn Firefighter Jason Walker and for the men and women protecting our safety on the streets of Berwyn, in the Armed Forces and for all Veterans.
- 3. The open forum portion of the meeting was announced. There being no speakers, the open forum portion of the meeting was declared closed.

MINUTES BERWYN CITY COUNCIL COMMITTEE OF THE WHOLE JULY 14, 2015

- 1. Mayor Lovero called the Committee of the Whole to order at 6:30 p.m.; upon the call of the roll the following responded present: Boyajian, Paul, Fejt, Polashek, Avila and Laureto. Absent: Chapman and Santoy. Thereafter, Avila made a motion, seconded by Laureto, to excuse Aldermen Chapman and Santoy. The motion carried.
- 2. Presentation regarding the City of Berwyn Water Shut-off Program: The Mayor recognized Finance Director Rasheed Jones, Assistant Finance Director Benjamin Daish and Assistant City Administrator Evan Summers who gave a Power Point Presentation. Jones explained this was needed to encourage delinquent residents to become current and prevent disconnection and would apply to those with balances due of over \$3,000 and over 90 days past due.
 - Stage 1: Disconnect notice letters would be mailed out specifying disconnection would take place 30 days after notice date and stating payment arrangements must be made with the Utility Billing Department, with payment plan request needing approval from the Finance Department.

Note: Alderman Santoy present at 6:35 p.m.

Stage 2: 30 days after disconnect notice letter is mailed, a sticker notice will be posted at the address which specifies disconnection date, no less than 5 days after sticker notice is posted. Sticker warns that the Berwyn Public Health District could require evacuation of premises as a result of water disconnection, along with a reminder that after disconnection, restoration of service may take, at minimum, one business day.

Stage 3: No less than 5 business days after sticker notice, the Finance Department will confirm that no payment arrangement has been made; Health District will be notified of water disconnection date and the Finance Director will issue approval for water disconnect to Public Works Director.

Stage 4: Restoration of Service. There will be a \$100 reconnection fee assessed to customer's account per ordinance. Restoration of water service requires payment of balance in full or enroll in Water Shutoff payment plan, which 50% down payment on entire account balance with remaining past due amount to be payable over a 6 month period. Failure to honor payment plan will result in water service disconnection.

COMMITTEE OF THE WHOLE July 14, 2015

Discussion ensued. The Mayor noted that service would not be shut off during winter months. Evan Summers noted that notice will be sent via USPS Certified and regular mail and City employees will tag the property after 30 days notice. Discussion ensued regarding the city's previous amnesty program, which very few residents took advantage of. The Mayor asked for a consensus to implement the new water shut off program, with council 7-0 in favor.

- 3. The Mayor asked if there were any questions and concerns with any agenda items. Clerk Pavlik requested that consent agenda item K-24 be pulled and that the block party request for 15th Street between Elmwood and Gunderson be denied per staff recommendation. Pavlik also noted that item K-11, a request form Ark Ministries was not finalized and that it be deferred for two weeks.
- 4. Alderman Fejt questioned item I-1, a request from Alderman Santoy to create an Ad Hoc Zoning Committee, asking if any recommendations from the committee be referred to the Building, Zoning and Planning Committee. Santoy explained that any recommendations from the Ad Hoc Committee will be brought before City Council. The Mayor suggested that any items that pertain to the BZP Committee be forwarded by the Ad Hoc Zoning Committee before their report comes to council.
- 5. The Mayor asked for a motion to close the Committee of the Whole for real estate contracts. Thereafter, Avila made a motion, seconded by Boyajian, to close the Committee of the Whole at 7:05 p.m. The motion carried.
- 6. A motion was made in Closed Session by Avila, seconded by Laureto, to reopen the Committee of the Whole at 7:24 p.m. The motion carried.
- 7. A motion was made by Santoy, seconded by Boyajian, to adjourn the Committee of the Whole at 7:24 p.m. The motion Carried

WHEREAS, the City of Berwyn ("CITY") is a Home Rule Unit of Government pursuant to and as defined in Article 7 Section 6 (a) of the 1970 Illinois Constitution; and

WHEREAS, said Section of the Constitution authorizes a home rule unit of government to exercise any power, and perform any function, pertaining to its government affairs; and

WHEREAS, the 1970 Illinois Constitution, Article VII Section 10 and the Intergovernmental Cooperation Act provide authority for intergovernmental cooperation; and

WHEREAS, the City will receive an annual grant from HUD for CDBG Programs, and the amount of said grant for October 1, 2015 to September 30, 2016 ("Program Year 2015") is expected to be \$1,205,473;

WHEREAS, the Mayor and the City Council have determined it is in the best interest of the City to receive CDBG funds from HUD for housing and related needs of low and moderate income persons; and

WHEREAS, the Community Development Department developed an Annual Action Plan for Program Year 2015 and also a Five Year Consolidated Plan for Program Years 2015 through 2019, pursuant to HUD regulations and in accordance with a Citizen Participation Plan which meets HUD's requirements; and

WHEREAS, the City developed the 2015 Annual Action Plan and Five Year Consolidated Plan to promote the development of a viable urban community, by providing decent housing and a suitable living environment and expanding economic opportunities, principally for low and moderate income persons, in conformance with HUD Act of 1974, as amended, and the HUD regulations applicable thereto; and

WHEREAS, after due deliberation the City Council finds it would be in the best interest of the CITY to approve and submit the CITY's 2015 Annual Action Plan and Five Year Consolidated Plan for Program Years 2015 through 2019 as drafted by the CITY's Department of Community Development.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF BERWYN, COOK COUNTY, ILLINOIS, as follows:

SECTION 1:

That the Corporate Authorities of the CITY herby approve the 2015 Annual Action Plan and Five Year Consolidated Plan for Program Years 2015 through 2019 in substantially the same format as attached hereto and made a part hereof as Exhibit A, and said final draft is hereby authorized to be submitted to HUD.

SECTION 2:

That all proper publications having taken place, public hearings having been held and the 2015 Annual Action Plan and Five Year Consolidated Plan for Program Years 2015 through 2019 having been available for public comment for over thirty days, all public comments and responses shall be included and submitted to HUD pursuant to Section 1 above.

SECTION 3:

That the Mayor and City Clerk are hereby directed and authorized to enter into on behalf of the CITY all contracts necessary and proper to fully implemented the 2015 Annual Action Plan and Five Year Consolidated Plan for Program Years 2015 through 2019; including, but not limited to, all contracts receiving or distributing any allocations of CDBG funds therein, all contracts under the Single Family Rehab Program, and as otherwise required to implement the 2015 Annual Action Plan and Five Year Consolidated Plan for Program Years 2015 through 2019.

SECTION 4:

That this Resolution shall be in full force and effect from and after its passage and approval according to the law.
