





The Berwyn City Council Minutes of the Regular Meeting of May 23, 2023

Mayor Lovero called the Regular Meeting to Order at 8:00 p.m. Clerk Paul called the roll. The following Alderpeople responded present in chambers: Lennon, Woywod, Leja, Fejt, Pabon, Ruiz, Arenella, and Carmichael. Mayor Lovero and attendees recited the Pledge of Allegiance. Mayor Lovero asked for a moment of silence in memory of Mary Disanti and Rosalba Lazo and in support of our First Responders.

Open Forum: Mayor Lovero opened the floor for Open Forum. The following people addressed the City Council members: Members of the Berwyn Tree Canopy Initiative reiterating request for increased funding for trees among other requests (copy of comments submitted for the record). Ms. Sandy VanGoethem thanked Berwyn Police for efforts to notify residents concerning possible civil disturbance and Fire Departments for early deployment of life-saving equipment.

Approval of Minutes:

C-1: Ald. Lennon made the motion, seconded by Ald. Fejt, to approve the Minutes of the Committee of the Whole and the Regular City Council Meeting of May 9, 2023 as submitted. The motion carried by a unanimous voice vote.

F-1: Ald. Carmichael made the motion, seconded by Ald. The motion passed with all eight Alderpeople voting AYE on the call of the roll.

Fejt, to concur and authorize the insurance renewal contract with Liberty Mutual Insurance for property, inland marine and auto physical damage coverage at the premium amount of \$160,066.00 with a \$25,000.00 deductible amount. The motion passed with all Alderpeople voting AYE on the call of the roll.

Ruiz, to thank business owner Tom Benson for his civic involvement and generosity, to authorize city staff to collaborate with the Tom Benson and family with their offer to once again sponsor the Independence Day Fireworks celebration in the city, and provide any city services necessary for the event. The motion passed by a unanimous voice vote.

Lennon, to approve the event application submitted by the Junior Statesmen of America – Morton West Chapter for their Juneteenth commemoration event to be held on June 17, 2023 at Serenity Park and authorize city services as requested. The motion passed by a unanimous voice vote.
