



The Berwyn City Council Minutes of the Regular Meeting of March 12, 2024

C-J

Mayor Robert J. Lovero called the Regular City Council Meeting to Order at 8:00 p.m. Clerk Paul called the roll. The following Alderpeople were present in chambers: Lennon, Woywod, Leja, Fejt, Pabon, Ruiz, Arenella, and Carmichael. Attendees rose to recite the Pledge of Allegiance. A moment of silence was observed in memory of Virginia Diaz, in memory of Thomas Becvar, and in support of the City's First Responders.

Open Forum: Mayor Lovero opened the floor for Open Forum.

- Micah Caldwell spoke urging council members to vote against agenda item F-2 that would change aspects of the City of Berwyn Plumbing Code.
- Domingo Ramirez spoke on discriminatory "Seat Belt Check" stops by Berwyn police, the lack of diversity in Berwyn city departments, the lack of assistance from police for a domestic matter.
- Natalia Perez provided an update on the work of the Christian Life Food Pantry.
- City Communications Manager Claudia Ayala distributed information on an additional Illinois Works
 Pre-Apprenticeship Program beginning in July 2024.

C-1 Approval of Minutes: Ald. Lennon made the motion, seconded by Ald. Arenella, to approve the February 27, 2024 Minutes of the Committee of the Regular City Council Meeting as submitted. The motion carried by a unanimous voice vote.
