# The Berwyn City Council Minutes of the Regular Meeting of April 23, 2024

Mayor Robert J. Lovero called the Regular City Council Meeting to Order at 8:00 p.m. Deputy Clerk Anderson called the roll. The following Alderpeople were present in chambers: Lennon, Woywod, Leja, Fejt, Pabon, Ruiz, Arenella, and Carmichael. Attendees rose to recite the Pledge of Allegiance. The Mayor took a moment to remember County Clerk Karen Yarborough, followed by a moment of silence in support of the City's First Responders.

Open Forum: Mayor Lovero opened the floor for Open Forum.

- 1. JSA Governor Yadilla Padilla updated the audience on the JSA events.
- Natalia Perez provided an update on the Christian Life Center Food Pantry at 34<sup>th</sup> & Grove Avenue.
- 3. PW Director Schiller reminded the audience that in honor of Arbor Day, the City of Berwyn will be planting a tree at the Library on Friday April 26, 2024.
- 4. Pink Divas and Gents member Janelle Morlin spoke about their organization's 5K Walk/Run event being held at Morton West High School on June 29, 2024.
- Deputy City Clerk Anderson confirmed an email distributed to Council Members regarding a Berwyn resident's concerns regarding the Ethics Commission.

Woywod, to adopt the Resolution entitled: Resolution Authorizing and Approving Intervention in Property Tax Assessment Proceedings, direct the Corporate Authorities to affix the necessary signatures and send it on its way to passage. On the call of the roll, the motion passed with all eight Alderpeople present voting AYE.

J-3: Ald. Leja made the motion, seconded by Ald. Lennon, to approve Police Chief Cimaglia's request to purchase (2) 2024 Ford Escapes to be used by the Community Service Division at a cost of \$58,056.00 (a price being honored by the price rollover and contract extension under the Ford SPC Contract #206). On the call of the roll, the motion passed with all eight Alderpeople present voting AYE.

**J-4:** Ald. Arenella made the motion, seconded by Ald. Ruiz, to approve the City Communication's Division request to approve/proceed with the Independence Day Celebration Fireworks on July 3, 2024. The motion carried by a unanimous voice vote.

J-5: Ald. Arenella made the motion, seconded by Ald. Leja, to approve the Berwyn Library's request to host their annual Summer Reading Challenge kick-off event on Saturday, June 8, 2024 between 10AM and 12Noon in the Library Auxiliary Parking Lot. The motion carried by a unanimous voice vote.
