July 26, 2016

1. The regular meeting of the Berwyn City Council was called to order by Mayor Lovero at 8:00 p.m. Upon the call of the roll, the following responded present: Chapman, Boyajian, Paul, Fejt, Santoy, Polashek, Avila and Laureto.
2. The Pledge of Allegiance was recited and a moment of silence was given for the family of Ronald N. James, father of Alderman Nora Laureto and grandfather of Berwyn Firefighter Michael Laureto.
3. The open forum portion of the meeting was announced. The Mayor spoke regarding the successful Pokémon Go event held on July 25<sup>th</sup> with plans of another is underway possibly in August and the Berwyn Police Explores were passing out blue lights for use on front porches in support of our law enforcement. Alderman Chapman spoke of the great turnout at the Pokémon event with included over a 1,000 attendees of all ages, Chapman is also seeking sponsors for Family Pavilion at this year's Oktoberfest. Resident Wilma Salvatore read a letter of gratitude and support for our local city services and thanked the Fire Department's Chief and Red Shift for saving her home, pets and other neighbor's homes during a recent fire. Residents of the 2<sup>nd</sup> Ward addressed concerns of the parking situation surrounding 3D Collision, Paisans Pizzeria, the 24 hour residential parking restrictions and addressed concerns regarding rodents. 2<sup>nd</sup> Ward Alderman Boyajian and the Mayor stated that all their concerns were noted and will be addressed.
